UTC Member Advocacy & Policy Update

ICYMI

- On December 28, UTC filed comments on the FCC's proposed changes to the existing 3.5 GHz Citizens Broadband Radio Service rules. The FCC in October proposed changes to the existing 3.5 GHz rules which were approved in 2015. In particular, the FCC sought comment on whether it should increase the size and terms of priority access licenses (PALs) within the 3.5 GHz band (GN Docket No. 17-258). In its comments, UTC argued against such changes, stating that doing so will negatively impact utilities already operating mission-critical services in the band. Extending the terms of the licenses to 10 years and expanding their geographic size may make it difficult for smaller entities—including utilities—from acquiring a PAL in an auction. Additionally, they may be forced to acquire licenses that are too large or too long for their needs, UTC said.
- In November, U.S. Senators Thune (R-SD) and Schatz (D-HI) released a discussion draft of potential legislation meant to "speed the deployment of 5G." UTC has led a coalition of utilities and trade associations in meetings with U.S. Senate staff to explain utilities' concerns with the proposal. Those meetings will continue over the next few months as the Senate Commerce Committee continues discussing next steps. UTC has a number of concerns with the current version of the Thune-Schatz as drafted. So far, we have met with staff for Senator Moran (R-KS), Senator Johnson (R-WI), Senator

- Capito (R-WV), Senator Daines (R-MT), and Senator Gardner (R-CO). Details about these meetings will be shared during the monthly PPD call, scheduled for January 18 at 2:00 PM Eastern.
- A few weeks ago, UTC requested members to submit ideas for policy resolutions that will be considered at the annual conference to be held in May 2018. This will mark the first time UTC pursues policy positions through the resolution process as approved by the UTC Board in its December 2017 meeting. Under the process approved by the Board, UTC staff will send the solicitation in November of each year; however, because the Board only took action last month, the solicitation for resolutions to be considered at the 2018 Telecom & Technology conference was sent in January. Resolution ideas must be submitted by UTC core utility members and must be received no later than January 31, 2018.

This Month

- On January 9, the House Energy and Commerce Committee's Subcommittee on Energy held a
 hearing "DOE Modernization: Advancing DOE's Mission for National, Economic, and Energy Security
 of the United States." The hearing begins a series "in which members will explore what is necessary
 to ensure effective execution of the DOE's core national, economic and energy security mission."
 The Subcommittee will be hearing from numerous DOE officials and others.
- Comments on the FCC's notice of proposed rulemaking pertaining to pole attachments and the IP transition on are due on January 17. UTC will be filing comments and held a conference call to discuss our positions on January 9, 2018.
- UTC's PPD's monthly conference call will be held January 18, 2018, at 2:00 PM Eastern.
- On January 18, UTC's Board of Directors Chairwoman, Kathy Nelson, spoke at the U.S. Energy
 Association's (USEA) annual <u>State of the Energy Industry Forum</u>. The annual forum brings together
 leading executives from the most influential and active energy trade associations to present their
 views, exchange ideas and engage in dialogue on major cross cutting issues facing the energy
 industry for the year. It was a tremendous opportunity to introduce UTC to this audience and
 highlight our key issues.
- UTC staff will be joining over 13,000 industry stakeholders at DistribuTech 2018. The 15-track conference "brings industry thought leaders from all over the world opportunities to network, share knowledge and problem solve with worldwide utilities and product and service providers. At its next Open Federal Communications Commission (FCC) Meeting on January 30, 2018, the FCC will consider a <u>Public Notice</u> establishing procedures for the Connect America Fund Phase II auction, which will award up to \$1.98 billion over 10 years to service providers that commit to offer voice and broadband services to fixed locations in unserved high-cost areas. (AU Docket No. 17-182; WC Docket No. 10-90). The draft <u>Public Notice</u> indicates that the CAFII auction will be scheduled for July 24, 2018 and the deadline for submitting short form applications to participate in the auction will be March 30, 2018.
